

RAVNAIR GROUP FLYAWAY SWEEPSTAKES

OFFICIAL RULES

Important: Please read these Official Rules before entering this Sweepstakes (the “Sweepstakes”). By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. PURCHASE OR PAYMENT WILL NOT INCREASE ODDS OF WINNING.

Sweepstakes void where prohibited by law. Subject to applicable federal, state, and local laws.

- Eligibility:** The Sweepstakes is open only to individuals who are legal residents of Alaska, are at least 18 years old, and members of the RavnAir FlyAway Rewards program (joining is free -- see <https://www.flyravn.com/flyaway-rewards/> for signup details) at the time of entry. Directors, officers, members, managers, and employees of RavnAir Group (“*Sponsor*”) and any of its parent companies, affiliate companies, subsidiaries, agents, village agents, professional advisors, advertising, promotional, public relations, and fulfillment agencies, consultants, legal counsel, website providers, web masters, and immediate family members (spouses, parent, child, sibling, grandparent, and “step” child, wherever they may live) of each are not eligible to win any prize. **IF YOU DO NOT MEET ANY OF THESE REQUIREMENTS, OR ANY OTHER ELIGIBILITY REQUIREMENTS IN THESE OFFICIAL RULES, YOU ARE NOT ELIGIBLE TO WIN A PRIZE.** To be eligible to win a prize, entries must be completed and received by Sponsor in the manner and format designated below.
- Sweepstakes Period:** The Sweepstakes starts at 12:01 a.m. Alaska Time on June 5, 2019 and ends at 11:59 p.m. Alaska Time on June 30, 2019 (the “*Sweepstakes Period*”). All entries must be received during the Sweepstakes Period and meet other requirements in these Official Rules to be eligible to win a prize. Sponsor’s or its designee’s computer is the official time-keeping device for the Sweepstakes.
- How to Enter:** To enter, during the Sweepstakes Period, complete the steps for either of the following methods of entry:

Purchase Method of Entry: (i) Visit flyravn.com/sweepstakes and follow the instructions to (ii) submit an entry form and (iii) purchase a flight through flyravn.com/sweepstakes. Each purchase of a one-way flight ticket will result in one entry (subject to the entry limit below). Purchases of tickets for other individuals (e.g., friend, family member, or any other non-business traveler) will count as entries for the individual purchasing the tickets, so long as the buyer meets the eligibility requirements in these Official Rules. For clarity, and by way of example, if an eligible individual buys two round trip tickets for the individual and one family member consistent with these Official Rules, then he or she will earn four entries.

Free Mail-In Method of Entry: Mail a single 3 x 5 card with your name, address, and email address to RavnAir Group, 4700 Old International Airport Road, Anchorage, AK99502 with “RavnAir Fly Away Sweepstakes” or “RavnAir FlyAway Swoopstakes” written at the top or the bottom of the card. P.O. Boxes are not permitted. Each mail-in entry must be postmarked separately during the Sweepstakes Period and be received within 7 days to be eligible.

Limit: FIVE ENTRIES PER PERSON DURING SWEEPSTAKES PERIOD, REGARDLESS OF METHOD OF ENTRY. Any attempt to obtain additional entries, including through multiple or duplicate accounts will result in disqualification.

If participating in this Sweepstakes via your mobile device (which service may only be available via select devices and participating wireless carriers and is not required to enter), you may be charged for standard data use from your mobile device according to the terms in your wireless service provider’s data plan. Normal airtime and carrier charges and other charges may apply to data use and will be billed on your wireless device bill or deducted from

your pre-paid balance. Wireless carrier rates vary, so you should contact your wireless carrier for information on your specific data plan.

4. **Identity of Entrant:** All entries must be submitted by the individual entrant. Bulk or automated entries will be disqualified (including entries made using any script, macro, bot, or promotional service). Multiple participants are not permitted to share the same email account. Any attempt to obtain additional entries through fraud or other illegitimate means will result in disqualification, at Sponsor's discretion.

In the event of a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address submitted with the entry. An "**authorized account holder**" means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide Sponsor with proof that a potential winner is the authorized account holder of the account associated with the winning entry.

5. **Selection and Notification of Winner:** On or about July 10, 2019 Sponsor will select the names of three potential winners of the prizes in a random drawing from among all eligible entries at Sponsor's headquarters as listed in Section 15 below. The odds of winning depend on the number of eligible entries received.

Each potential winner will be notified via email on or about July 12, 2019. To the fullest extent permitted by applicable law, Sponsor may require each potential winner to sign and return, within seven days of being notified, an Affidavit of Eligibility and Liability/Publicity Release in order to claim his/her prize. If (i) the attempted notification is returned as undeliverable without a forwarding address; (ii) any required documents are not returned within seven days, such as the Affidavit of Eligibility and Liability/Publicity Release; or (iii) if potential winner is otherwise unable to accept the prize as stated, the prize will be forfeited and may be awarded to an alternate winner. Alternate drawings will be held until prizes are awarded. If, by reason of a print or other error, more prizes are claimed than the number set forth in these Official Rules, an alternate winner will be selected in accordance with the above selection process from among all eligible claimants making purportedly valid claims to award the prizes available.

Verification of Potential Winner: EACH POTENTIAL WINNER IS SUBJECT TO VERIFICATION BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES. 6. Prize: One First Place Prize winner will win \$10,000. One Second Place Prize winner will receive \$2,000. One Third Place Prize winner will receive \$1,000. Approximate Retail Value ("ARV") of all prizes: \$13,000.

Prize Restrictions: LIMIT 1 PRIZE PER PERSON. ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZE ARE THE SOLE RESPONSIBILITY OF THE WINNER. No substitutions or exchanges of any prize (including for cash) will be permitted, except that Sponsor reserves the right to substitute a prize of comparable or greater value for any prize. Sponsor will not replace any lost or stolen prizes or prize components. Only the number of prizes stated in these Official Rules are available to be won in the Sweepstakes.

Except for applicable manufacturer's standard warranties, the prizes are awarded "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied (including any implied warranty of merchantability or fitness for a particular purpose).

6. **Disclaimer:** Sponsor, and any of its respective parent companies, subsidiaries, affiliates, directors, officers, professional advisors, consultants, contractors, legal counsel, public relations firms, employees and advertising, fulfillment and marketing agencies (collectively, the "**Released Parties**") will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) phone, electronic, hardware, software, network, Internet, or other computer or communications-related malfunctions or failures beyond Sponsor or the Released Parties' reasonable control; (c) any Sweepstakes disruptions, injuries, losses or damages caused by events beyond the reasonable control of Sponsor or the Released Parties by non-authorized
